

Summer 2010 Financial Aid Application for CONTINUING PLU Students

Financial Aid for Summer Term *is limited to graduate students and Continuing undergraduate PLU Students only*, and only Direct loan, Pell grant and Alternative loans are available. You must be registered at least half time (6 credits for undergraduates, 4 credits for graduates) to be eligible for Direct loans. The amount of your Direct loans for the summer depends upon your enrollment for the coming year. If you use some of your eligibility for the summer, your loan eligibility for the rest of the academic year will be reduced by the amount borrowed in the summer and the loan amounts will be divided equally over the number of terms for which you have loan eligibility. Your summer aid eligibility will be based on the information you provide below, as well as the information you provide on the FAFSA.
