**Sexual assault** is unwanted sexual contact.

**Rape** is forced sexual intercourse, including vaginal, anal or oral penetration. Penetration may be by a body part or an object.

Rape victims may be forced through threats or physical means. In about 8 out of 10 rapes, no weapon is used other than physical force. Anyone may be a victim of rape: women, men or children, straight or gay.

Intimate Partner Violence (IPV) is a pattern of behavior in any relationship that is used to gain or maintain power and control over an intimate partner. It is also may be called domestic violence, partner abuse, or relationship violence.

Abuse is physical, sexual, emotional, economic or psychological actions or threats of actions that influence another person. This includes any behaviors that frighten, intimidate, terrorize, manipulate, hurt, humiliate, blame, injure or wound someone.

Domestic violence can happen to anyone of any race, age, sexual orientation, religion or gender. It can happen to couples who are married, living together or who are dating. Domestic violence affects people of all socioeconomic backgrounds and education levels.

**Stalking** is a pattern of behavior that makes you feel afraid, nervous, harassed, or in danger. It is when someone repeatedly contacts you, follows you, sends you things, talks to you when you don't want them to, or threatens you.

You can be stalked by someone you know casually, a current boyfriend or girlfriend, someone you dated in the past, or a stranger. Stalking is a crime and can be dangerous.

- You can contact Campus Safety (CSIN) at any time with questions or concerns, regardless of whether you are reporting a crime or not.
- A criminal act is wrong, regardless of the intention behind it. CSIN encourages, but does not require, all students to file reports of incidents involving sexual assault, intimate partner violence and stalking.
- •CSIN can help a students make a report to the Pierce County Sheriff's Department (PCSD). Depending on the nature of the incident, CSIN may be required to contact PCSD as well.
- CSIN is required to report and act on any activity that they feel poses any kind of threat to one's self or others.
- •If you choose to file a report with CSIN, CSIN will respect your privacy, however some repots may be automatically forwarded to the Off ice of Student Rights and Responsibilities.
- If you decide not to file a report with CSIN, you have the option to be provided with appropriate information for campus resources.

#### What is Title IX?

Title IX is a federal law that ensures that all students are treated with equity regardless of their gender. The Title IX coordinator works with all of the departments outlined in this brochure to make sure your rights are upheld.

- The PLU Student Code of Conduct protects the rights of all members within our community through policies related to sexual assault, intimate partner violence, and stalking.
- The Student Conduct System is an educational process. Please contact the Associate Director if you would like to pursue a specific incident through the Conduct System or for general questions.
- Once a written report is received by the Associate Director, the following steps will be taken:
- The incident will be investigated and reviewed by a conduct board through separate meetings with students named in the report and others as deemed necessary.
- The Review Officers will make a decision of Responsible, Not Responsible or Inconclusive.
- If found Responsible, the Review Officers will assign sanctions based on the nature of the incident. Sanctions may include educational assignments, meetings, counseling, or a recommendation of suspension, or expulsion.
- For more information, please see the procedure flow chart or reference the Sexual Misconduct or University Violence Prevention Policies on the SR&R website.
- This office addresses incidents that occur both on and off campus and is separate from any process that may occur outside of PLU.
- •The Associate Director is available to answer question and provide options, regardless of whether you are reporting an incident.

- Many individuals have found Victim Advocacy to be a good starting point for getting the help they need.
- The Victim Advocates provide a safe, private place for individuals who have questions or concerns about sexual assault, intimate partner violence, or stalking.
- A professional Victim Advocate and trained peer advocates are available to provide emotional support and help you meet your immediate needs by:
- Arranging referrals for medical care, including obtaining a rape exam, pregnancy and STD testing, and emergency contraception.
- Acting as a liaison to address any concerns with academics or campus services.
- Discussing options for reporting to Campus Safety or local law enforcement.
- Developing a safety plan and obtaining Orders for Protection.
- Providing referrals to counseling or support groups on campus and in the community.
- Helping family and friends understand how to best support their loved one who has been victimized.
- Victim Advocates will provide you with options and resources to make informed choices and will support and empower you to make the decisions you feel are best for your situation.
- •Victim Advocates are confidential professional but may be required to report any statements indicating serious harm to one's self or others.

# Campus Sexual Assault Victims' Bill of Rights

Federal law requires colleges and universities to afford the victims of campus sexual assaults certain basic rights.

- During disciplinary proceedings, the accuser and accused must have the same opportunity to have others present.
- Both parties shall be informed of the outcome of any disciplinary proceeding.
- Survivors shall be informed of their options to notify law enforcement.
- Survivors shall be notified of counseling services.
- Survivors shall be notified of options for changing academic and living situations.
