## **Important Notice Regarding ACH Direct Deposit**

Pacific Lutheran University (PLU) is pleased to offer payments to vendors and other payees by means of ACH direct deposit, in lieu of issuing checks. To take advantage of this fast, safe and secure method of payment, we encourage you to take a few minutes to complete the authorization and enrollment form on the opposing page of this notice.

The deposit to your bank or financial institution account is effective on the day following the Accounts Payable check run. The weekly check run is usually processed on Thursday (maybe earlier depending on our holiday schedule). A remittance advice will be emailed to you on the same day as the Accounts Payable check run.

Benefits of ACH direct deposit method of payment include:

- Faster payment quicker access to your money
- Eliminates the possibility of a lost/stolen check
- Saves time and the gas it takes to drive to and from your financial institution to deposit or cash a check
- Reduces paper use by eliminating the need to print and mail a check in an envelope
- Supports PLU's commitment to practice and promote sustainability
