# SUMMARY ANNUAL REPORT

# For Pacific Lutheran University 403(b) Retirement Plan

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan for Pacific Lutheran University 403(b) Retirement Plan, EIN 91-0565571, Plan No. 001, for period January 1, 2023 through December 31, 2023. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single-employer defined contribution plan.

### **Basic Financial Statement**

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$17,907,513. These expenses included \$381,297 in administrative expenses, and \$17,526,216 in benefits paid to participants and beneficiaries. A total of 1,563 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$233,582,745 as of December 31, 2023, compared to \$212,015,699 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$21,567,046. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$39,474,559, including employer contributions of \$3,401,893, employee contributions of \$2,649,456, other contributions of \$1,448,019, earnings from investments of \$31,738,798 and other income of \$236,393.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (Pacific Lutheran University, 12180 Park Avenue South, Tacoma, WA 98447) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
