Alternate Route to Certification – Secondary/SPED



The MAE Alternative Routes with Secondary and Special Education Certification has two options. Students can choose to complete both the certification and the degree requirements, or complete the certification portion only.

- The certification portion is 24 semester hours from summer 2025 to spring 2026, plus 18 credits of Continuing Education coursework for the special education endorsement.
- The remaining 10 credits for the MAE degree can be completed within 3 years (by spring 2028).

Tuition is based on a cohort model. Students must complete the program with their cohort to remain eligible for cohort pricing. Tuition for 500-Level education coursework is \$971 per credit. Tuition for 900-Level special education coursework is \$250 per credit. (Courses for special education endorsement are not eligible for federal loans but scholarships may be available.)

Total tuition for certification program with special education coursework (42 credits): \$27,804 (\$971 per credit)

Total tuition w/MAE (52 credits): \$37,514 (\$971 per credit)

Additional fees include: technology fee (\$270/year), wellness fee (\$110/year), a one-time matriculation fee (\$205), books and materials for coursework, certification, fingerprinting, etc. (*Subject to change*)
