## **Old Business:**

Building Inspections: Joe Bell reminded everyone that L & I regulations require building inspections. Our buildings are set up on an approximate 4 year rotation for inspection, which amounts to 8 – 10 buildings per year. Joe asked for volunteers from the Safety Committee to accompany him during the inspection of buildings that are due by the end of Spring semester. Inspections take approximately 30-40 minutes to complete.

## **New Business:**

1. Injury reports as of January 19, 2017: 3 injuries in Dining Services, One injury in Facilities.

Dining Services- Cut/Puncture while cutting bread, no lost time. Slip/Trip/Fall while walking in the parking lot, 2 days lost time. Burn while cleaning coffee filters, no lost time

Facilities-Slip/Trip/Fall on ice outside Reike, no lost time.

2. Annual Injury Report-

2016 – 42 injuries, 10 recordable resulting in 6 lost days and 100 restricted duty days.

In comparison to -

2105 – 20 recordable resulting in 13 lost days and 217 restricted duty days.

3. We will be hearing from OSHA regarding new walking surface regulations. This will not require facilities to de-ice parking lots, however. Some discussion regarding possibly alerting the Residential Director to put up emergency signs when it is icy ensued. It was decided that properly communicating with the RD would be too problematic and that we would continue with operations as we have been, which is relying on common sense of those on campus.
