### **Call for Additional Agenda Items**

**Trauma Care Training-** Joe Bell and Greg Premo have organized a training session for June 15<sup>th</sup>, 9am to 12 noon in the Regency room at the Anderson University Center. Training is targeted towards those with CPR, EBC and Search and Rescue training. Call Ext 8787 or contact Greg Premo for registration for the class.

Peirce County Recue has purchased for PLU 48 trauma kits. These kits will be distributed to the same locations as the EBC kits.

**Construction Alerts-** There will be a lot of summer construction projects this summer. Be aware of restrictions and allow for additional time to maneuver around work areas. Contractors are bound to PLU safety standards while on PLU property.

Car chases ending on PLU property- a brief discussion on the MAST article. The MAST article articulated that some were disappointed that a PLU alert was not issued but as the incident unfolded and carefully monitored by Campus Safety; the incident did not rise to a level meriting a PLU alert. Peirce County Sheriff would have requested am alert if they felt it was justified but again, the incident was over in a matter of seconds. SC suggested that a proactive statement from Campus Safety after the incident may have been sufficient should a similar event occur in the future.
