Questions from Complainant (and we don't have to ask them all!)

- Did you and Simone have anything alcohol that evening, together or before the two of you hung out?
- Page 7: Respondent shared that he could read body language. What does that mean/look like?
- Page 6: Respondent said that he received verbal consent. What exactly was said?
- Page 7: The Respondent shared that they switched to anal sex. Was there consent?
- Page 14: Shares "signs of discomfort." What did that look like? If there was discomfort, why did you suggest another position?
- In the areas of discrepancy section on page 7, the respondent refers to the complainant's body language. What did the body language mean?
- How did my body language show a "desire to engage in this type of activity?
- On page 7 the respondent stated that the complainant "had a place to be." Do you remember that conversation or where I needed to be?
- On page 7 in reference to the Snapchat conversation in which the complainant said she wanted to talk to the respondent about the previous day, the respondent said he told her "there was nothing to talk about." If you wanted to "still be friends" why would you not want to talk about what happened, especially after I told you I was not okay? Why was there "nothing to talk about?"
- On page 14 the respondent says it seemed like the complainant wanted to be in the room (his room). What made it seem like I wanted to be in the room?
- On page 14 the respondent says that he was getting "only positive vibes" from the complainant. Can you please speak to that? What did that look like?
- On page 14 the respondent claims that the complainant was willing to do anything. Did the complainant ever state verbally that she was "on board with anything?"
- On page 14, Please elaborate on the quote that the complainant was "moving her hands on me in sensual ways." What did that look like?

- On page 14 paragraph 5, How did the complainant express that she "didn't seem to mind "(about the fact that she was a virgin)? Please elaborate.
- On page 14 paragraph 6 what were the "signs of discomfort" you noticed in the complainant? Did the complainant say anything to express the discomfort?
- On page 15 the respondent states,"the complainant was hoping the sex wouldn't be a one time thing." What made you think that? Please elaborate on this conversation.
- On page 15 the complainant talks about the sex as something "we both just executed." This implies that this was a mutual experience where both parties were fully participating. Was I "executing", or just laying there?
- On page 16 you state that you responded to witness 4 by saying "who?" when she gave you my name as someone who she had spoken with and was making allegations. Then, you had to look up my name to help you remember. If you can't even remember my name or what I looked like, how can you remember everything that happened? And a follow-up to that question- How many other girls did you have questionable sexual experiences with who might possibly be alleging this that you had to look it up to remember which one it might be? Please address this.
- On page 17, when the no-contact order was being instituted, why did you think the no-contact order was "weird", given what witness 4 had told you about my experience or that I felt unsafe?
- My question from page 16 is: What changed in your life from the time you spoke with the complainant about not wanting a relationship at the end of February to being in a "Facebook official" relationship just a few weeks later at the beginning of April?
- On page 17, paragraph 7, you state that you don't want to have the stigma of the college boy who "just wants to get some", however, you had to look up the person's name, who you had wonderful, respectable, consensual sex with just a few weeks before? Can you please speak to how this differs from the "college boy who just wants to get some"?
